## **BEACON HILL REPORT** by Thomas Joyce, Esq.

I was pleased to join you at the Sturbridge Host Hotel this past week and talk to many of you individually about the big job ahead at the Statehouse. Sadly, during my luncheon legislative update, back in Boston, the House of Representatives was debating an Ethics Committee order to expel one of its members due to his criminal incarceration, which prevented him from adequately representing his constituents. The order was ultimately overwhelmingly adopted. Representative Carlos Henriquez was the first House member expelled since 1906.

Just to recap my remarks, recall that after a very successful legislative year in 2013 the MTCA is faced with a huge task this year. You will recall that in November the joint committee on Election Laws favorably reported, and the House passed an election bill that provides for early voting for 10 days prior to the 2016 Presidential elections. Importantly, the bill provides that Clerks may allow the vote to occur in their office with it limited to normal business hours. Additionally the bill provides for on-line voter registration, and much of the agenda long sought by the MTCA. Then merely a few weeks ago the Senate passed an elections bill containing nearly every conceivable reform put forward by the advocate community, much of which may be impossible to comply with. For a more detailed description of the bills see the January Recorder.

The two bills, House Bill 3788 and Senate Bill 1981 are now before a 6 member conference committee to reconcile the differences (2 democrats and 1 republican from each branch.) The three House members are Chairman James Murphy of Weymouth, Representative Michael Moran of Brighton and newly elected Representative Shaun Dooley of Norfolk. The Senate members are Chairman Barry Finegold of Andover, Senator Sal DiDomenico of Everett and Senator Robert Hedlund of Weymouth.

I have been working hard to persuade legislative leaders as well as the members appointed to the conference committee to recommend a bill that most favorably resembles the House Bill 3788. I have met with five of the six conferees and will be meeting with Senator Finegold on Thursday. My meetings have been quite positive thus far. I am confidant that if and when a final bill emerges it will have recognized our concerns.

As a matter of information there is no set schedule for the conference committee to meet and in fact no deadline to report. In fact there are presently five conference committees appointed and surely more to come before the end of the legislative session. A couple of those conference committees were appointed nearly six months ago. I hope to have good news to report before the Legislature prorogues July 31.

### ARCHIVES EDUCATION PROGRAM

The Massachusetts State Archives, Massachusetts Board of Library Commissioners, and the Graduate School of Library Information Science at Simmons College, in partnership with the Massachusetts Town Clerks' and Massachusetts City Clerks' Associations, has received a grant from The National Historical Publications and Records Commission to create an archives education program specifically designed for Municipal Clerks.

The program will focus on the management and preservation of town records, and consist of a Beginner series and Advanced series of courses. The first series is scheduled to begin in November 2014 with a face-to-face meeting followed by on-line instruction and assignments. The first series will have two sections, and the face-to-face meetings will be held in Boston and western Massachusetts. Each series will consist of several instructional modules with follow-up assignments. Presenters for the coursework include representatives of the faculty at the Simmons College

Graduate School of Library and Information Science, the Massachusetts State Archives, and the Massachusetts Board of Library Commissioners. Planned session topics include archival standards, electronic data, and digital preservation.

The tuition for each series is estimated at \$150.00. The support of town and city clerks, and that of each community throughout the Commonwealth, is critical to the effectiveness and success of this program. Registration for the fall 2014 archives education program will begin in June 2014. Please request support from your community for tuition to participate in this very informative and important series. # Municipal office-holders must file a change of purpose form if they decide to run for state or county office in 2014

Each state election year, many municipal officeholders decide to run for state or county office. In those cases, the campaigns must register with OCPF and may have dual filing requirements at the state and local levels.

Once a city or town candidate decides to run for state or county office, he or she must file a "change of purpose" form CPF 101P with OCPF and provide a copy of the form to their local election official.

In addition to the change of purpose form, a copy of a candidate's M101 organizational form from the local level should be filed with OCPF. Also, the candidate

should file with OCPF a copy of the summary page from the most recent campaign finance report filed with their city or town clerk.

Once registered with the state, the candidate will be given an identification number and password to allow them to file electronically with OCPF.

If a candidate continues to seek office at both the state and municipal levels, he or she will continue to file campaign finance reports at both levels.


