The Education Committee has come up with some great classes.

I have had several new clerks ask me about the CMMC, CMC, and MMC so I would like to briefly explain these. CMMC is Certified Massachusetts Municipal Clerk. This certification is earned by attending classes at our conferences, college degrees you have earned, experience as a Town Clerk, along with several other areas, and by taking an exam. The exam is given twice a year and you must be a Town Clerk for at least three years before you can take it. CMC is Certified Municipal Clerk and MMC is Master Municipal Clerk. Both of these certifications are administered by the International Institute of Municipal Clerks (IIMC).

In order to earn the CMC you must attend the three year Institute program at the New England Municipal Clerks Institute and Academy (NEMCI-A). Again, your experience and participation in your local and state associations help to earn the credit you need to apply for the certification. The MMC requires further education and one place to receive this is by attending Academy classes at NEMCI-A. The process to apply for these various certifications is not hard, but it is time consuming. Any clerk who has waded through the paperwork will be glad to help you with this process. In the past, we have had a class at a conference that goes through all these certifications and what is needed for each one. If you are interested in earning any of them, watch for this class at a future conference.

Congratulations to all the clerks who have retired over the last several months. We thank you for your many years of service and you will be missed. Welcome to the new clerks who are replacing them. This is a great association and any of us are only a phone call or e-mail away.

BEACON HILL REPORT by Thomas Joyce, Esq.

The legislature began 2014 quietly on the first Wednesday in January, huddled under the golden dome during a fierce snowstorm. The slow start accelerated with break neck speed on the 16th when the Senate debated and passed S1975, it's version of the elections bill. To say the bill as passed by the Senate is nearly impossible to implement, expensive, and the most far-reaching election laws initiative in the country may well prove to be an understatement. While it still includes provisions which the House adopted that we have long been advocating, Task Force, Cancellation Devices, Education of Election Officers, it also establishes some initiatives which the MTCA will have tremendous difficulty implementing in their current form.

Spearheaded by Senator Barry Finegold, the upper branch tacked on required election audits, preregistration for 16 and 17 year olds, Election Day voter registration, permanent voter registration for voters who move within the state and much expanded early voting to cover all state biennial elections. The bill requires an early election polling place to be open for 3 Saturday and Sunday hours in towns having 1 precinct and 10 hours if more than 1 precinct. Additionally, the Senate prohibits census non-filing as a reason for voter disqualification.

One of the few favorable provisions added during debate was an amendment to require the Commonwealth fund the hours for weekend offices that are required to be open. Another favorable amendment was doing away with the requirement for checkout tables. To be certain, these few provisions pale in comparison to the cumbersome changes the Senate endorsed.

At the conclusion of debate Senator Finegold stated, "this is a great bill strengthened by the amendments adopted." He said "with early voting and same day voter registration I think we are going to see a big increase in people participating and that's what we want in our democracy." He also cited other states dramatic increase in voter participation, naming California and Oregon in particular.

One huge caveat is that we live to fight another day. I have been assured that this bill along with the House passed election bill will be sent to a committee on conference to attempt to negotiate a compromise. While the House bill, H3788 demonstrated a practical and moderate approach to improving voter participation the Senate bill appears to be much more policy driven "as an all or nothing" approach to election reform.

In closing, I must say, that an objective observer of the Senate debate would be hard pressed to think of even one election reform the Senate failed to adopt. I assure you that along with the MTCA legislative committee I will be working tirelessly to convince the committee on conference to approve a bill that much more resembles the House version.

Legislative Update – President Nancy Blackmer

President Nancy Blackmer stated that the Legislative Agent, Tom Joyce had asked if he had to attend and at the time he asked there were no issues going on so she told him not to attend. However, since then the election bill had been progressing. She stated that the Bill #H3647 was in regards to the Election laws. The bill had 5 parts to it:

- 1. Online voter registration
- 2. Election Training for only the clerks and then they train staff
- 3. Cancellation Device
- 4. Study on Audits
- 5. Early Voting

Robert Cutler, Legislative Committee Member stated that Tom Joyce expects that there will not really be any changes and that the Bill is moving quickly. Many of the Clerks had many questions in regards to the Early Voting part of the Bill but Mr. Cutler said that there were many things to be worked out and he did not have the answers at this point yet.

Simmons College Project - President Blackmer stated that this project will not begin until July 2014.

1st Vice President Report – 1st VP Andrew Dowd reported that the Association awarded 3 scholarships for the Jiminey Peak Conference. He reminded the clerks to visit all the vendors throughout the day.

Raffles to Raise Money for Candidates or Political Committees? Not a Great Idea.

A town clerk recently called OCPF to ask whether a political committee could hold a raffle. It's a common question, especially for local party committees.

Based on advice from the Attorney General's office, our answer has always been no.

State law allows local election officials to issue permits to six specific types of organizations, and political committees are not listed in the statute and may not be issued permits, according to the Attorney General's office.

Campaign Finance Disclosure reports for Yearend 2013 are due Tuesday, Jan. 21.

OCPF will be available by phone to assist candidates and committees until 8 p.m. Tuesday for filing ques-

tions.

Depository candidates include statewide and county candidates, Governor's Council candidates and mayoral and city council candidates in Boston, Cambridge, Lowell, Springfield and Worcester. State parties are also in the depository system.

Non-depository candidates and committees also file year-end reports. These committees include legislative candidates, mayoral candidates in cities with populations of 40,000 to 100,000, PACs and independent expenditure PACs. Local party committees file with OCPF if they exceed \$100 in activity in 2013.

All other municipal candidates file on paper with their local election officials.


