This legislative year has proven to be very productive for the MTCA. Many bills we have supported or filed are moving favorably through the legislative process. Most importantly, legislators are seeking our input on public policy initiatives.

Association President Andy Dowd has met with Lt. Governor Polito and recommended policies to be adopted as the administration drafted its municipal modernization bill. In fact, that bill is scheduled to be debated by the full House the week of your Conference in Plymouth. Additionally, Andy Dowd has worked closely with the conference committee on Public Records Reform. That bill has recently been signed into law by Governor Baker (Chapter 121 of the Acts of 2016.)

Another Association sponsored issue; electronic poll books, has passed the House and is now awaiting Senate action. We are hoping this be-

The fiscal 2016 budget conference committee is working hard to reconcile differences and complete its work before the fiscal year ends on June 30th. A couple of items are in the House version that I reported on last month. Specifically, after changing residence to a new community the time period to register would be six months for this election year, and extending to 45 days prior to the election the time in which a municipality must notify residents of the places to conduct early voting.

Although the MTCA conference will have ended before you read this, I want to say how pleased I am that Representative Peter Kocot from Northampton is the 2016 MTCA Legislator of the Year. He is very responsive to the MTCA mission and is an extremely highly regarded public servant. Congratulations Chairman Kocot.

How to dissolve a political committee

With spring elections over, we get this frequently asked question: "When or how can I dissolve my political committee?"

Generally, two types of candidates want to dissolve their committees – incumbents who didn't run for reelection and have been replaced, and unsuccessful candidates. Local ballot question committees also dissolve shortly after the question has been decided by the voters.

To dissolve, campaigns must have a zero balance by paying unpaid bills, forgiving or repaying loans to the candidate, and/or donating residual funds to a charity, scholarship fund, municipality or the state.

When the candidate reaches a zero balance, he or

she can then file the regular CPF M102 form and check the "dissolution" box at the top of the form's cover sheet. The dissolution report is filed with the local election official.

If a losing candidate has a zero balance and no liabilities when the 30-day after report is filed, but does not check the dissolution box, it's OK to consider the committee closed.

Candidates can stay active, even if they are not in office. If a candidate wants to remain active, he or she must file a year-end report, due Jan. 20, 2017.

MTCA CERTIFICATION EXAM (CMMC) IN JULY

The MTCA examination for Certified Massachusetts Municipal Clerk (CMMC) designation will be offered in July. Applications must be received by Administrator Barbara LaBombard by **JUNE 30**th for the July exam, which will be mailed between July 16th and 23rd.

Applicants must have at least **three years** experience as <u>Town Clerk</u> and must complete a minimum of six required courses sponsored by the MTCA

The Administrator will verify the courses through the Education Committee. More information is available in the certification program brochure.

Completed exams must be postmarked no later than August 25th for the July exam. Applicants are <u>strongly</u> urged to return the completed answer sheets by <u>certified mail</u>, return receipt requested.

Applicants will be notified by mail of the results

of their exams by September 15th. A copy of the notification must be submitted with the application for MTCA certification. The notification of successful completion of the exam will be valid for one year and will have an expiration date printed on it. If an applicant is not certified within one year, the test must be repeated.

A non-refundable fee of \$50.00, made payable to the MTCA, must be submitted with the application. This examination is offered twice yearly – during the months of January and July. Application forms for the examination are available from the administrator, Barbara LaBombard. FULL MEMBER Full members are Municipal Clerks, City Secretaries, Recorders, Legislative Administrators and Directors of Corporate Services and/or an individual who serves a Legislative Covernment Redy (LCR) in an administrative capacity with management responsibilities and whose duties include four of			

who serves a Legislative Government Body (LGB) in an administrative capacity with management responsibilities and whose duties include four of the following: • General Management • Records Management • Elections • Meeting Administration • Management of by-laws, Articles of Incorporation, ordinances or other legal instruments • Human Resources Management • Financial Management • Custody of the official seal and execution of official documents.

ADDITIONAL FULL MEMBER

Additional Full Members are fully qualified members from the same organization. This would essentially be Deputy Clerks within the same City, but could be other individuals provided they would qualify under the definition of Full Member. A city must have one Full Member before they would be eligible to have Additional Full Members.

ASSOCIATE MEMBER
Associate Members are individuals serving a legislative body in a capacity not previously defined. In other words if someone serving a legislative body does not qualify for Full Membership they would be able to join as an Associate Member. Associate members have the right to vote, BUT CANNOT hold office or obtain certification, but they can take advantage of education programs and should they eventually assume the job of Clerk or Deputy, they could then apply for certification. A Full Member who is in transition (between jobs) would automatically become an Associate Member until they reassume the position of Clerk. Associate members would also pay a lower fee.


