BEACON HILL REPORT by Thomas Joyce, Esq.

Congratulations for once again conducting a seamless experience at the polls for Massachusetts voters recently! You are applauded for a job well done, the unsung heroes in the election process

Statewide, the voter turnout was a bit less than the forecast with approximately 54% of registered voters casting ballots. I suppose not too bad for a non-Presidential election year. However, I am always amazed that more people just do not vote.

In the marque race for Governor, Charlie Baker won by a 2% margin, just over 40,000 votes. A close race to be sure but as is often said a win is a win, particularly by a Republican given the small number of registered Republicans in the Commonwealth. I had to research back 50 years to find a smaller margin of victory for Governor. In 1964 John Volpe defeated Frank Bellotti by 27,000 votes. Interesting, given that two years earlier Volpe, as the then incumbent Governor, had lost to Endicott Peabody by a mere 5500 votes. In fact, recent history indicates Republicans usually win the "corner office" by relatively small margins. Bill Weld beat John Silber in 1990 by less than 75,000 votes (although in 1994 Weld beat democrat Mark Roosevelt by nearly a 70-30 percent margin!)

Governor Elect Baker deserves a lot of praise and credit for running a nearly flawless campaign. I am certain we wish him much success! I should also congratulate the tremendously successful campaigns run by political newcomer Maura Healey for Attorney General, Bill Galvin for State Secretary, Suzanne Bump for Auditor and Deb Goldberg for Treasurer. I wish them well also.

Perhaps closer to home in the Legislature, after a slew of special elections over the last eighteen months, seventy incumbent legislators faced challenges last week while there were 8 seats open. Two Republican Representatives won election to the upper chamber, Senators-elect Vinny deMacedo from Plymouth, who ran for the seat being vacated by Senate President Therese Murray and Ryan Fatman who beat longtime Democrat incumbent Richard Moore from Uxbridge. Additionally 2 Democrats, Rep. Anne Gobi from Spencer

and former Rep. Barbara L'Italien from Methuen won open Senate seats. In 2015 the Senate will be comprised of 34 Democrats and 6 Republicans.

Over in the House of Representatives as of today there will be 2 recounts. One in Democrat Rhonda Nyman's district, which includes Hanover and the other, is the open seat vacated by Democrat Rep. Michael Costello that includes Newburyport. Republicans very narrowly won both of those seats. Additionally, a Republicans defeated Democrat Rep. Denise Andrews from Orange and won 5 open House seats as well. If those two elections withstand recounts the House will continue to hold a large Democratic majority; 125-35 (Republican net gain of 6 seats.)

While Governor Elect Baker is moving quickly to assemble his team House Speaker DeLeo and incoming Senate President Rosenberg will wait until the end of January or early February to announce their leadership teams.

Very exciting times lay ahead! As always, I will report new developments.

MTCA CERTIFICATION EXAM (CMMC) IN JANUARY

The MTCA examination for Certified Massachusetts Municipal Clerk (CMMC) designation will be offered in January. Applications must be received by Administrator Barbara LaBombard by **DECEMBER 15th** for the January exam, which will be mailed between January 1st and January 7th.

Applicants must have at least **three years** experience as <u>Town Clerk</u> and must complete a minimum of six required courses sponsored by the MTCA.

The Administrator will verify the courses through the Education Committee. More information is available in the certification program brochure.

Completed exams must be postmarked no later than February 10th for the January exam. Applicants are strongly urged to return the completed answer sheets by certified mail, return receipt requested.

Applicants will be notified by mail of the results of

their exams by March 1st. A copy of the notification must be submitted with the application for MTCA certification. The notification of successful completion of the exam will be valid for one year and will have an expiration date printed on it. If an applicant is not certified within one year, the test must be repeated.

The passing score for the exam is 80. Applicants are advised that they will need access to an updated copy of the Massachusetts General Laws to complete the exam successfully.

A non-refundable fee of \$50.00, made payable to the MTCA, must be submitted with the application. This examination is offered twice yearly – during the months of January and July. Application forms for the examination are available at all MTCA conferences and from the administrator, Barbara LaBombard - (cityclerk@easthampton.org) or by calling 413 -529-1460.




