Dear Representative Smola:

I am requesting, on behalf of the MA Town Clerks Association, the following consideration:

"Clerks are the foundation of the election process in the Commonwealth of Massachusetts as the Chief Election Officer, and we consider ourselves to be essential workers in the administration, conducting and processing of all things relative to an election whether it is a local, special or state election."

In the past year Town Clerks have worked in the safest manner possible, utilizing all safety precautions of course, but we have placed ourselves at extreme risk during COVID-19 to insure that the work, which must be done in the administration of an election continue.

It is for this very reason that I am requesting that a consideration of placing clerks in a category, which would allow for the vaccination(s) to be given to them as a protection from this virus as soon as possible given that towns will be holding their elections in either March, April, May or June.

Many clerks have served their communities for a lengthy period, a sizeable percentage of these clerks are also over the age of fifty (50) years of age, and nevertheless our ability to be exposed is the same. I am well aware as President of this MA Town Clerks Association of the many clerks who are now suffering from COVID 19, have been quarantined due to exposure and others who are in the recovery stage. Most of the clerks do not have Assistants, nor are there replacements available. The many clerks who have retired after years of service to their respective communities were called in to help during the State Election of 2020. The position of Chief Election Officer for any City or Town in Massachusetts, as you may be aware, is not one where an individual can simply be appointed and take over without proper training and adequate knowledge of the election process.

It should be noted, that many communities across the Commonwealth have seen clerks resign or leave after what was probably the most difficult and trying election season in the history of this state due not to their ability to perform their jobs, but rather because of the concerns and fear that their health could be compromised at a time when so many of them were in the last years of service to their communities and a desire to retire in good health.

Should consideration for granting a change to allow the clerks, who are considered essential workers, be made, I would respectfully request notification as to how we can proceed in as quick a manner as possible as many clerks have local elections scheduled early in March.

Thank you for allowing me to forward this letter to you, I know you will act quickly to bring it to the forefront of discussions with Governor Charles Baker and the Department of Public Health, both of whom are charged with insuring for proper procedures and categorizing.

Good Morning:

The staff at State Auditor Suzanne Bump's Division of Local Mandates (DLM) hopes this finds you and your loved ones safe and in good health.

As you may know, a line item in the FY21 state budget appropriated \$3.02 million for reimbursement to cities and towns for costs incurred implementing state-mandated vote-by-mail and in-person early voting requirements for certain 2020 elections. The line item also directs DLM to certify these costs in advance of distribution of state funds to affected municipalities by the Secretary of State's office. With your help, we plan on completing our cost certification work for submission to Secretary Galvin by May 2021 so that all communities can receive reimbursement as soon as possible.

As a result, within the next week, DLM will forward an email to all 351 municipal elections officials that announces our certification work and which includes a link to our electronic cost form. In the meantime, prior to release, we would like to review with you the structure of our cost form and the specific types of vote-by-mail and in-person early voting cost and other information we will be requesting from you for these 2020 elections. Our new electronic cost form, although lengthier because it covers more elections in 2020, is similar to those that you completed for early voting in 2016, 2018, and for the 2020 March presidential primary. This form is comprised of an Instructions page; Sections A through G; and ends with a page for the Certification Clause, as follows:

Instructions. Please review the Instructions, as they explain each Section of the cost form and the types of costs that are, and are not, eligible for state reimbursement under DLM's Local Mandate Law. Included in the Instructions is DLM staff contact information if you have any questions about completing the form.

Section A: Contact Information. Please double check that your email address is spelled correctly in order to receive a completed form to your email in-box. Our form also allows you to save and forward a partially completed form to your inbox to finish at a later time if necessary.

Section B: 2020 Postponed Spring Local Elections. This Section applies to towns that conducted 2020 postponed local elections and thus were required to comply with the new state-mandated vote-by-mail provisions of Chapters 45 and 92 of the Acts of 2020. If applicable, Question 2 asks whether your office Incurred no more than incidental expenses, or received CARES Act funding from EOAF or reimbursement from another source such that your net cost was incidental. If "Yes", please click NEXT at the bottom of the page and proceed to the next Section of the survey. Answering "No" will allow you to enter incurred expenses. Eligible costs, if applicable, include notifications provided to voters about the rescheduled local election; postage to mail ballots to registered voters; and expenses incurred to hire additional personnel to process both vote-by-mail applications and submitted ballots from registered voters. When listing total expenses and average hourly rates of pay, only include additional workers hired to handle these tasks or regularly scheduled staff if they earned overtime rates of pay. Do not include the time of regular hourly or salaried staff working during their normal business hours. Other eligible expenses include the rental of private space to process vote-by-mail

applications and ballots. In addition, you will also be asked in this and other Sections of our form to detail amounts of any reimbursements you may have received from, for example, EOAF CARES Act monies, the Secretary of State's office, and/or from private sector sources. This will allow us to compute a DLM-certified total <u>net</u> state reimbursement amount owed to your community from the FY 21 state budget appropriation mentioned above. The end of Sections B through G will also include a 'Comments' box for you to include any other information you would like DLM to consider.

Section C: 2020 Postponed State Special Elections. The questions in this Section are structured similar to Section B above for those communities that were involved in 2020 postponed state special elections.

Section D: Mail in Ballots for the September 2020 State Primary. For processing mail-in-ballots for the 2020 September state primary as mandated by Chapter 115 of the Acts of 2020, Question 1 in this Section asks whether your office Incurred no more than incidental expenses, or received CARES Act funding from EOAF or reimbursement from another source such that your net cost is incidental. If "Yes", please click NEXT at the bottom of the page and proceed to the next Section of the survey. Answering "No" will allow you to enter expenses incurred for mail-in ballots for the September 2020 state primary. Eligible costs include postage to mail ballots to registered voters; expenses incurred to hire additional personnel to process vote-by-mail applications and submitted ballots from registered voters; and expenses for data-entry of the mailed-in ballots into the Secretary of State's VRIS database. When listing total expenses and average hourly rates of pay, only include additional workers hired to handle these tasks or regularly scheduled staff if they earned overtime rates of pay. Do not include the time of regular hourly or salaried staff working during their normal business hours. Also, please do not replicate personnel expenses in Section E. For example, if an individual was tasked with VRIS data entry of both mailed-in and in-person early voting ballots, please count their hourly rate of pay and expenses once. Other eligible expenses include the rental of private space to process September 2020 state primary vote-by-mail applications and ballots and unreimbursed expenses to purchase drop boxes. Please only enter these costs as a one-time expense, if applicable. In addition, in order for DLM to compute net cost impacts as mentioned in Section B above, you will also be asked to detail amounts of any reimbursements you may have received from, for example, EOAF CARES Act monies, the Secretary of State's office, and/or from private sector sources.

Section E: In-Person Early Voting for the September 2020 State Primary. For implementing in-person early voting for the 2020 September state primary, Question 1 in this Section asks whether your office Incurred no more than incidental expenses, or received CARES Act funding from EOAF or reimbursement from another source such that your net cost is incidental. If "Yes", please click NEXT at the bottom of the page and proceed to the next Section of the survey. Answering "No" will allow you to enter expenses incurred for in-person early voting for the September 2020 state primary. Eligible costs include expenses incurred to hire additional personnel to process in-person early voters and to enter early voter information into the Secretary of State's VRIS database. When listing total expenses and average hourly rates of pay, only include additional workers hired to handle these tasks or regularly scheduled staff if they earned overtime rates of pay. Do not include the time of regular hourly or salaried staff working during their normal business hours. Other eligible expenses include the rental of private space to process in-person early voters and their ballots for the September 2020 state primary during required voting hours; costs incurred to set up and take down inperson early voting areas; and any unreimbursed expenses to modify polling places and/or purchase any personal protective equipment (PPE) or other protective measures. Please only enter these costs as a one-time expense if applicable. Please do not include costs incurred during optional early voting hours (hours not mandated by state law); or for operating voluntary additional early voting sites; or expenses for optional voter tabulation facilities; or for police expenses. In addition, in order for DLM to compute net cost impacts as mentioned in Section B above, you will also be asked to detail amounts of any reimbursements you may have received from, for example, EOAF CARES Act monies, the Secretary of State's office, and/or from private sector sources.

Section F: Mail in Ballots for November 2020 General Election. The questions in this Section are structured similar to Section D: Mail in Ballots for the September 2020 State Primary above. In this section, please do not include expenses associated with counting of mail-in ballots received after election day.

Section G: In-Person Early Voting for the November 2020 General Election. The questions in this Section are structured similar to Section E: In-Person Early Voting for the September 2020 State Primary above.

The last page contains the **Certification Clause** and fields for your contact information. When you click **Finish** you will receive a copy of your completed form in your email inbox for your records.

We hope this preview is helpful to you as DLM prepares to officially launch our cost certification work next week. Please save this preview for future reference for when you receive our official electronic cost form. Also, after project launch, DLM will be offering assistance in the form of webinars and phone consultations to make completing and submitting our cost form as easy for you as possible.





Q1 Do you plan on attending the MTCA conference in Plymouth MA, June 9th - 11th?







Extension of March 31st EV by mail provision

Many of you have inquired about the status of the Bill that would extend early voting by mail beyond March 31st. Our Lobbyist, Secretary Galvin, and our friends in the legislature are all aware of the need for an extension and are strongly advocating for it. This Bill was filed in January but has not yet been heard: House Docket 240 (https://malegislature.gov/Bills/192/HD240/Bills), "An Act further providing for early voting by mail, will extend the current provisions allowing for early voting by mail in municipal elections from March 31, 2021 to June 30, 2021. Given the continued public health concerns surrounding COVID-19, this extension will be particularly helpful in protecting the safety of voters participating in upcoming town elections this spring, many of which are scheduled after March 31". Please encourage your reps and senators to support this extension.

Election Law Changes Proposed for 2022

As most of you are aware, there have been numerous Bills filed which would make changes to the Election Laws and incorporate many of the temporary provisions from 2020. The voter advocacy groups are making an extremely strong push to ensure these changes are made prior to the 2022 election cycle. They are also advocating for Same Day Registration and longer periods of in-person Early Voting. As Nancy Talbot mentioned in her recent e-mail, Michelle Tassinari put together a working group to review proposed changes that Secretary Galvin would propose through legislation. Both the MTCA and MCCA Presidents designated representatives to serve on this working group. The group met for 3 consecutive weeks and had some very productive discussion. We were able to reach consensus on many of the issues. One thing that was very clear to our diverse group was that the legislation needs to contain provisions that would provide for some flexibility based on a community's size and unique characteristics.

Once the legislature begins to review the various proposals, I expect the debate to focus on these issues:

Same Day Registration or Election Day Registration - the voter advocacy groups desperately want Same Day Registration. If passed, that would eliminate the voter registration deadline and allow people to register on election day AND during any early voting sessions. Election Day Registration, which is being proposed by Secretary Galvin, would maintain a voter registration deadline, and would not allow people to register during early voting sessions. Those are significant differences and EDR would be much easier to manage. During the working group's discussions with Michelle Tassinari, she felt including EDR in Secretary Galvin's Bill would be the best way to avoid ending up with Same Day. In general, the members of the working group agreed with that tactic. I'm certainly not implying that any of us are thrilled about it, but it may result in a much more manageable system.

- No Excuse Vote by Mail Secretary Galvin's Bill would allow for no excuse vote by mail. The important
 difference with this proposal is, it WOULD NOT require the State to mail postcards to all voters as they
 did in 2020. Voters would need to take action to request a ballot, much like they do now with
 absentee ballots. That is a significant difference and would result in a much more manageable volume
 of requests.
- Extended periods of in-person Early Voting our own statistics have shown that in-person EV for
 primaries is not needed, we saw a very low turnout across the state. Conversely, in-person EV for
 general elections is very popular and voters have already grown accustomed to having this additional
 option. The Secretary's Bill does propose 7 days of EV for primaries and 14 day of EV for general
 elections. I feel we can make a strong argument for eliminating EV for primaries and reducing EV to 7
 days for general elections. Keep in mind the voter advocacy groups want both and for similar long
 periods.
- Fixing the Fall State Primary Date the working group agreed that moving the primary to August would work better for most. Secretary Gavlin's Bill did not incorporate this change.

Many of the other provisions from the temporary 2020 Covid legislation would be made permanent:

- Vote by Mail no excuse
- Drop Boxes
- Advance processing option
- May vote in person ED or EV if VBM ballot not returned
- Count ballot if returned before voter died
- Appointment of poll workers without regard for pollical party
- Check out list not required
- Extended deadline to return mail ballots by mail after Federal election only
- Polling location changes mailed notice not required

Copies of the proposed Bills are attached.

Technology Upgrades - new VRIS system

The State has indicated that we will have a new VRIS system in place prior to the 2022 election cycle. This will be an important tool to help us manage and track the current requirements and be better equipped to handle other election law changes.

Not being able to gather in person for conferences during the past year has certainly been challenging. The MTCA Executive Board will be meeting this Thursday and will review the proposed legislation. Additional updates will be provided as the process moves forward. Please keep in mind, these are only PROPOSALS, we

have a long way to go before they become law. At the conclusion of the legislative process, the updated election laws will likely contain items we fought hard for and items that we adamantly opposed. That is the reality of the process.

Dear Town Clerks:

Secretary William Galvin released to the media his proposals under Election Law Reforms the other day, the proposed Election Law changes that he will be submitting to the legislature for consideration this year.

It is my understanding that many of our legislators will also be filing bills with regard to election laws and changes.

I know you are all aware of the many changes that have transpired during COVID-19 and of the emergency regulations that were placed in effect because of the virus. Many of the new proposals are a direct result of those changes.

I was contacted after the November 3rd election by Michelle Tassinari as was Nicole Crispo who is President of the City Clerks Association. Michelle knew that in January there would be proposals by the legislature for consideration, and she realized that the Secretary would also be submitting new and revised election laws.

It was for this reason that after a lengthy conversation with Nicki and myself that we agreed with her that it would be wise to have a few clerks participate in discussion and collaboration to put forth proposals that had input from those at the state elections division and us as clerks.

As your President, I was asked to choose a few clerks as part of this collaboration, and I chose our MTCA officers (Bob Cutler, Liz Greendale, Lynn Sibley; as well Andy Dowd our Legislative Chairman; Danielle Sicard who has worked feverishly on our behalf and who previously has testified before the legislature, and Dottie Powers. I felt that this was a wise choice of individuals from various sized communities and a fair representation of our association. The City Clerks Association also chose a few individuals to be part of these discussions, Michelle did not want a large working group but one that could make suggestions as well as discuss the items that were being proposed by the Elections Division.

We met three Fridays and there was a lot of discussion and comments about the many items you have heard about. Andy Dowd has shared with his legislative committee members the proposals and I am sure is waiting for feedback in order to proceed further. Andy has always shared the information and recommendations of this group and I know this will continue.

We all agreed at our last session that prior to the actual filing of the proposed legislation we would once again meet.

Please know that we are working on your behalf, that there will be many hearings, and yes, there will be changes to everything that may be proposed by both Secretary Galvin and any of the legislators who are proposing things.

We all offered suggestions as to what is feasible, what is applicable, and what we know may not work in many instances for one or more reasons, but I assure you we worked on your behalf.

I do hope that this helps to clear any of the concerns you may have after seeing Secretary Galvin speaking with the media, but I was not surprised. I believe he was trying to insure that everyone including the legislature was aware that he would be addressing "same day registration", Early Voting and other needed changes as part of the Election Law Reform in Massachusetts.

If you are looking for a few more points of view: I do hope we can avoid having BOTH vote by mail and in person early voting. What the Legislature (and Gavin) might forget is that many of us are also juggling local (fall) Town Meeting and Elections at the same time.

As an example, I was out of my mind last fall trying to run 14 days of early voting for Nov 3; preparing for Nov 3 (strategizing and planning for Central Tab Facility etc); while simultaneously preparing for a Nov 14 Special Town Meeting and a Dec 3 debt exclusion vote. I felt like I was breaking rules when I had my early voting poll workers sitting at the poll pads AND putting stickers on vote by mail envelopes for the upcoming local debt exclusion vote. Two sets of envelopes circulating in the same room. I did not like the potential that something would get mixed up but I had no choice. The Town Manager wanted the mailed ballots for the Dec 3 vote to go out before the Nov 14 STM.

While we all have an interest in increasing/maximizing voter turnout for elections, too much going on at the same time can increase the likelihood of error. And yes I encountered some errors that I am still working on.

Dear Nancy,

I would like to fervently request for standardized training, procedures (not just regulations) and forms. It is no longer enough to tell Clerks what needs to be done. The experience level is so varied and lack of standards has placed Clerks in jeopardy as we saw last fall. I think that this is a reasonable ask from the Legislature and may keep clerks from retiring or resigning due to the unreasonable strain this puts on offices without separate elections departments.

I'm talking about precinct clerk reports, tally sheets (not blank block tally sheets, but write-in and hand count tally sheets), Clerk logs. There should be state-wide training for election workers in the varied positions so that we can draw from a pool of workers rather than relying on (and hoping for) alert and aware workers from within our town.

I think that Michelle believes every town/city wants to do its own thing. I've gotten enough calls and requests for my material (not the best, but the best that I can do) that I know we really don't want to do our own thing. We want to do the right thing and we should all be doing it the same way. This doesn't infringe on our independence, rather it provides a huge sense of relief.

We have very talented Clerks like the ones you named working with Michelle in recent weeks – the time has come and providing these types of resources will make all this far more palatable.

Hi Larry

Thank you for your email. Unfortunately the Task Force created in 2014 did not meet as was intended in that legislation. I met with the members individually the summer they were supposed to convene. When Senator Finegold returned he convened a meeting but there is no official obligation beyond the action they were required to take after 2016 changes were implemented. I do think the MTCA should push for a permanent Task Force and required it to meet with the legislature before they approve election bills. Both Andy and I, along with our lobbyist spoke regularly with the leadership of the joint committee on election laws before passing the 2020 fall elections bill – that was unprecedented and a step in the right direction. Although we did not get heard on all accounts and we were not completely satisfied with the end result of the legislation, I can assure you that what we ended up with was far better than what it would have been without our advocacy. We will continue to vet and handle the new election legislation bills current being submitted the same way and we are hopeful that our input will continued to be welcomed and valued by leadership.

Hi Danielle and Sergio,

Long time, no see! Hope all is well with you and your families.

I am writing to you to express my concerns regarding the fact that, with all the election law changes that took place in 2020, the

Legislative Task Force on Election Law and Integrity was never called to discuss the proposed changes before they were enacted into law. Understanding that it would have been

difficult to meet in person, I do not understand why a zoom meeting could not have been arranged. I fear that the same situation is going to exist

regarding the newest proposals by the Secretary of the Commonwealth (SOC). Since three of us on the Task Force are Municipal Clerks, it would be another

opportunity for Clerks' concerns to be heard.

Since I was appointed to the Task Force by Senator Bruce Tarr in 2019, the group has met only one time (October, 2019). Ordinarily, that may have sufficed, but given the

dynamic situations over the past year, I think the lack of any communication was inappropriate. I am writing to you both with the hope that you might have

heard of an upcoming meeting of the Task Force, of which I am not aware. If that is not the case, I plan to contact Senator Finegold to ask him to call a meeting (zoom or otherwise)

of the Task Force to discuss the SOC's proposals, and, the need for input from the City/Town Clerks before enacting any new, permanent legislation.
